Table booking terms and conditions

- All bookings are subject to a deposit, pre-order or minimum spend (this will be discussed with you when confirming your booking).
- All deposits are non-refundable.
- Please note your booking is not confirmed until an e-mail response is received in reply to the terms and conditions including agreement of understanding of all points.
- In the event the booking is cancelled by the guest, the deposit is only refundable if the cancellation is made at least 72 hours before the day of the booking or under mitigating circumstances.
- We reserve the right to refuse entry and return any deposits to a party upon arrival, at our discretion (please see "conditions of entry")
- If a party is going to be more than 15 minutes late for the allotted booking time please contact the host on 07803361052.
- We will always endeavor to contact the party if we suspect they are going to be late, but in the event that we cannot make contact, we will hold the table for 30 minutes only then it will be re-sold or given to another guest and the deposit will be lost.
- Any damages incurred to the property or equipment by any of your party will be charged to the card that paid the deposit.
- We reserve the right to refuse entry to any additional people not accounted for in the booking party size.
- All guests must have proof of I.D and must be 18 years of age or over regardless of area booked.

Music policy

Salt Dog Slim's and 81LTD have an existing music policy that fits our concept guidelines. In the event of a private function we can cater to the guest's music requirements. This will be discussed as part of the booking procedure. In the case of 83 private hire, for an additional fee a D.J can be provided or music from 81 will be shared.

Guest Safety

At Salt, Dog, Slim's, 81LTD and 83 (collectively 7983LTD), the safety and security of our staff and guests is paramount. 7983LTD operate a minimum check 21 policy. If you are lucky enough to look younger than 21 then please be prepared to prove your age with valid and current identification. This can be a UK driving license, passport, or PASS identification card bearing the PASS hologram. This check 21 policy and strictly over 18 entry policy is also applied to all private hire functions, day time functions where alcohol is served and private use of 83. 7983LTD work in conjunction with local authority guidance, and operate an ID seizure policy whereby false ID will be confiscated and handed over to the police. 7983LTD support the responsible consumption of alcohol and reserve the right to refuse service to guests who are, or appear to be, intoxicated; this includes guests of private hire functions. Tap water is freely available in all our bars upon request. A random search policy of all guests may be implemented depending on prevailing conditions, risk assessment or police advice. 7983LTD operate a zero tolerance policy on drugs. Guests suspected of dealing or using drugs will be asked to leave the premises immediately. Guests are advised that we work continually with local authorities to ensure all venues are fully compliant on all aspects of health and safety and crime and disorder. CCTV is in operation in all areas.

Conditions of entry and accessibility.

7983LTD management reserves the right to refuse admission. Dress code is Smart/casual - please note we do not allow hats, hoodies, sports wear or highly visible branded clothing.
